**Please Note: *The party size cannot exceed twenty (20) people.*** Guest Passes are required for all non-resident guests over the age of five (5). (If the pool is closed for weather or any other reason prior to your event, NV Pool guards will make every attempt to notify you.) **Guest passes are non-refundable.**

*Parties are allowed non-exclusive use of the eating area. **Food must be confined to the eating area.***

*Per the pool rules, adult to child ratio requirement for pool parties is one adult for every three (3) children under the age of 5.*

Pool Rules state: Section 5. Limitations. For safety purposes the following limitations apply to pool use:

- a. Persons who are 12 years old and younger must be accompanied and closely supervised by a competent person aged 16 years or older (“Responsible Person”) at all times in order to use the pool.
- b. Persons who are 13, 14 and/or 15 years old must be accompanied by a Responsible Person at all times UNLESS the relevant 13-15 year old has satisfactorily passed the Association’s designated swimming test and secured written notice from the lifeguard that the swimming test was passed, provided proof of age and has on file a written authorization from a parent or guardian to utilize the pool without an adult. The swimming test and written notice must be provided to the Association prior to the relevant person’s use of the pool. Qualified 13-15-year-old persons who have received permission to use the pool alone may NOT have guests without a Responsible Person also present.
- c. Persons who are 16 years old and older may use the pool by themselves and may bring guests who must follow all Pool Rules.
- d. At no time shall more than three (3) persons age 5 years old and younger be under the care and/or custody of one Responsible Person.
- e. At no time shall more than five (5) persons between the ages of 5 and 15 years be under the care and/or custody of one Responsible Person.

## Pool Party Information Sheet

Small pool parties can be accommodated during normal operating hours for Stone Ridge residents and their guests providing the party does not interfere with the use and enjoyment of other pool members. Pool parties are reserved on a first-come, first-served basis and must meet the following criteria:

Host: Only a Stone Ridge resident may host a pool party. The host is responsible for the conduct of all party attendees and will ensure that guests comply with all rules. The host must be in attendance during the entire party and must remain as long as their guests remain at the pool.

Party Size: **The party cannot exceed twenty (20) people including the adults.** There must be one adult for every three (3) children under the age of 5 and one adult for every five (5) children between the ages of 5 and 15.

Dates: Pool parties are not permitted on the last day of school, during holidays, or on any three (3) day holiday weekend.

Scheduling: A pool party cannot last more than two (2) hours. Only three (3) pool parties may be scheduled on a given day and may not be held at the same time. Pool parties must be scheduled at least one (1) hour apart, within time slots offered (11am-1pm; 2pm-4pm; 5pm-7pm).

Guest Passes: Guest passes for non-residents must be purchased at the Association office during business hours. Association office hours are Monday – Friday 9am – 5pm and Wednesday 9am – 8pm.

A request for a pool party must be made *at least* seven (7) days prior to the event to allow planning for adequate guard staffing. The list of attendees must be complete at the time of application with Stone Ridge Association.

The Association will review the request form, and if approved a copy will be e-mailed to the person requesting the party. The Pool Manager will remind the host parent that (1) all pool rules must be followed at all times or party participants will be escorted from the facility and (2) all food must be confined to the snack room.

Pool parties must vacate the snack room at the conclusion of the party, **properly dispose of all trash, and leave eating area in pre-party condition.**

*Alcoholic beverages are strictly prohibited.*
